Tacos Committee – 75 attended.

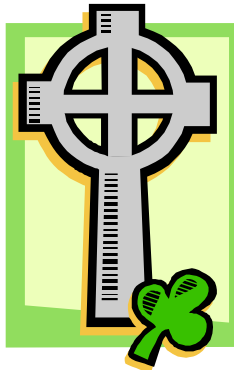
Pancakes Committee – 137 attended.
